ORDINANCE #2617, December 9, 1996

INTRODUCED BY Dixie M. Flynn, County Legislator

WHEREAS, under Title III of the Superfund Amendment and Reauthorization Act, enacted by Congress in 1986, the County joined with other units of local government in the area to form the Mid-America Local Emergency Planning Committee, which is operated by the Mid America Regional Council (MARC); and,

WHEREAS, the operations of such committees are funded by the proceeds of a fee paid to the states by companies who have or store hazardous wastes at their facilities; and,

WHEREAS, the Missouri Emergency Response Committee has remitted to the County the sum of \$37,381.00 as its share of these funds; and,

WHEREAS, the County is required to provide these funds to MARC to support the activities of the Local Emergency Planning Committee; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made from the unappropriated surplus of the 1996 Health Fund:
