qualified for Bright Flight, and received the University of Missouri Curators Scholar Award; and,

WHEREAS, Stephanie has taken and excelled in advanced courses throughout her schooling,

received academic letters from her freshman through her junior years, and maintained her place on

the principal's honor roll throughout high school; and,

WHEREAS, Stephanie plans to attend the University of Missouri and will be participating in Honors

College; and,

WHEREAS, Stephanie's parents, Wayne and Sue, and her brothers, Danny and Scott, join in

Stephanie's celebration of this distinguished award; now therefore,
