WHEREAS, the Family Court Division has been awarded the Family Drug Court Program Grant by the State of Missouri Drug Courts Coordinating Commission, for the period July 1, 2022, to June 30, 2023; and,

break the cycle of addiction and avoid the crimes that often accompany addiction; and,
