WHEREAS, the Director of Human Resources advised that she is in need of an independent investigation to be conducted on a pending employment matter; and,

WHEREAS, Angela D. Gupta of Associates in Dispute Resolution, LLC (ADR), of Kansas City (Jackson County), MO, is a well-qualified lawyer, experienced in providing the needed type of legal services; and,

WHEREAS, ADR has estimated that it can perform this investigation at a cost of \$15,000.00; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Counselor be and hereby is authorized to execute a Legal Services Agreement with ADR of Kansas City, MO, for a term ending June 30, 2020, at a total cost to the County not to exceed \$15,000.00; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance and Purchasing be and hereby is authorized to make all payments, including final payments on the contract.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
