AN ORDINANCE amending a plan in District GB-p (general business-planned development district) by allowing a 3,600 square foot addition to an existing building located on a certain 2.5-acre + tract.

ORDINANCE 2873, November 16, 1998

INTRODUCED BY Dennis Waits, County Legislator

WHEREAS, by Ordinance dated April 4, 1994, the County Legislature authorized a rezoning for a planned development pursuant to the application of Richard and Carol Hays (R-415); and,

WHEREAS, Richard and Carol Hays now wish to amend their plan by adding a 3,600 square foot addition to an existing building located on a tract of land described as follows:

Description: A 2.5 + acre lot is generally located at the southwest corner of Cowherd Road and Missouri Route 7 and is legally described as Lot 2 in Pin Oak Acres, a subdivision in Jackson County, Missouri aka 26307 E. Cowherd Rd.

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

Section 1. The Legislature, pursuant to the application of Richard and Carol Hays (RP-98-125) requesting the amendment embodied in this ordinance and with notice that the Jackson County Planning Commission favorably recommended this application in a public hearing on October 29, 1998, does adopt this ordinance pursuant to the Jackson County Charter authorizing the Legislature to exercise legislative power pertaining to planning and zoning.

Effective Date: This Ordinance shall be effective immediately upon its passage by the County Executive.
