WHEREAS, Truman Charitable Foundation's "KC Pact" program provides substance abuse prevention services for pregnant women and is headquartered at Truman Medical Center; and,

WHEREAS, Truman Charitable Foundation has requested \$115,000.00 in anti-drug sales tax matching funds to secure the continuation of this federally-funded program through the Department of Health and Human Services; and,

WHEREAS, these funds will be used as the local match to a federal grant in the amount of \$503,640.00 for this program; and,

WHEREAS, the Prosecuting Attorney has reviewed this proposal and recommends the expenditure of these funds; therefore, BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive is hereby authorized to enter into an agreement, a copy of which is attached and incorporated herein by reference, with Truman Charitable Foundation for its "KC Pact" program; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance be and hereby is authorized to make all payments, including final payment on the Agreement...Attorney
