WHEREAS, the Parks and Recreation has advised that all of the three bidders are acceptable to the department for the award of the contract, and,
WHEREAS, due to the minimal difference in fees quoted among the three bidders, the Purchasing Director is referring this request for proposals to the Legislature without a recommendation; now therefore,
BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that a license to provide concessions services at the Frank White, Jr., and 140th and Holmes Blue River Softball Complexes is awarded to J. E. Gross Concessions of Blue Springs, MO, for a monthly fee payable to the County in the amount of \$3,360.00; and,
BE IT FURTHER RESOLVED that the Purchasing Director be and hereby is authorized to execute any documents necessary to the accomplishment of the award.  Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
