**RESOLUTION # 16314,** June 4, 2007

**INTRODUCED BY** Bob Spence, County Legislator

WHEREAS, pursuant to Section 2836, Jackson County Code, 1984, the City of Raytown, MO, has requested the use of its County Urban Road System (CURS) funds in the amount of \$398,820.09 to cover the cost of the 63<sup>rd</sup> Street Bridge Project; and,

WHEREAS, the Director of Public Works recommends approval of the request; and,

WHEREAS, the Legislature finds that the 63<sup>rd</sup> Street Bridge Project by the City will benefit the citizens of Raytown and the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that, pursuant to Chapter 28, Jackson County Code, 1984, the Director of Finance and Purchasing is authorized to issue a check in the amount of \$398,820.09 as a lump-sum payment to the City of Raytown to fund the 63<sup>rd</sup> Street Bridge Project.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
