A RESOLUTION authorizing the County Executive to execute an Agreement with UtiliCorp United, Inc., granting an easement for the installation, operation, and maintenance of electrical transmission and distribution lines across a portion of the Little Blue Trace.

RESOLUTION # 13940, December 10, 2001

INTRODUCED BY Fred Arbanas, County Legislator

WHEREAS, UtiliCorp United, Inc., has requested the grant of a permanent 80-ft. easement across a portion of the Little Blue Trace for the installation, maintenance, and operation of electrical transmission and distribution lines to provide additional services to its customers in the County; and,

WHEREAS, the requested easement is 4,231 ft. in length and runs parallel and adjacent to the north right-of-way of I-470, near its interchange with View High Drive; and,

WHEREAS, for this easement UtiliCorp United, Inc., will pay the County compensation in the amount of \$64,631.25, representing \$.25 per square foot; and,

WHEREAS, the Missouri Department of Natural Resources has reviewed the request and has no objection to the grant of the easement; and,

WHEREAS, the Director of Parks and Recreation and his staff have reviewed the request and determined that the grant of the easement will not adversely affect the usability of the area of the
