RESOLUTION NO. 19086, February 22, 2016

INTRODUCED BY Alfred Jordan, County Legislator

WHEREAS, by Resolution 18339, dated December 2, 2013, the Legislature did authorize the execution of a Collective Bargaining Agreement (CBA) with Local Union No. 42 of the International Association of Firefighters, regarding the terms and conditions of employment of members of its bargaining unit within the Office of the Prosecuting Attorney; and,

WHEREAS, article XVIII, section 2B. of the CBA contains a provision that bargaining unit members may receive step increases on July 1 of each year; and,

WHEREAS, a merit pool increase was authorized as part of the 2016 budget to be implemented
retroactive to January 1, 2016; and,
WHEREAS, the Prosecuting Attorney recommends the execution of the attached amendment to the
CBA to change the effective date of step increases for bargaining unit members from July 1 to
January 1 for the remainder of the Agreement; now therefore,
BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive
be and hereby is authorized to execute the attached Letter of Understanding with Local 42 of the
International Association of Firefighters; and,
BE IT FURTHER RESOLVED that all County officials be and hereby are authorized to execute any
and all documents and take any other actions necessary to give effect to this Resolution.
