WHEREAS, the Family Court Division has been awarded a grant in the amount of \$67,212.00 by the Missouri Department of Social Services, Division of Youth Services, for the period of July 1, 2008, through June 30, 2009; and,

WHEREAS, the grant funds will be used to fund the After School Supervision Education & Treatment Program, which provides academic and skill building activities when the highest rate of recidivism occurs for the delinquent population; and,

WHEREAS, an appropriation is necessary to place the grant funds in the proper spending accounts; now therefore,
