ORDINANCE 2749, October 27, 1997

INTRODUCED BY Fred Arbanas, County Legislator

WHEREAS, the Parks and Recreation Department will sponsor its 1997 Christmas in the Park event from November 26 to December 31, 1997; and,

WHEREAS, at this event, held at the Longview Lake Campground, visitors will tour by automobile lighted holiday displays erected by parks staff; and,

WHEREAS, the costs of the event are paid out of donations collected from those viewing the displays; and,

WHEREAS, the department has traditionally used volunteers from various community organizations to assist the department in traffic control and collecting donations at the event; and,

WHEREAS, as compensation for supplying the volunteer staff, the department proposes to pay each participating organization a share of the total proceeds collected for the event in an amount not to exceed \$1,000.00 per organization; and,

WHEREAS, for 1997, the department proposes to contract with the organizations listed on Attachment A for their services; and,

WHEREAS, the form contract attached as Attachment B provides a suitable mechanism for the implementation of this arrangement; and,
