RESOLUTION # 11855, August 11, 1997

INTRODUCED BY John C. Graham, County Legislator

WHEREAS, by Resolution 11264, dated April 29, 1996, the Legislature authorized the County Executive to execute an agreement with Public Water Supply District #16, in connection with the Fields Road Bridge Replacement Project, No. 2314, to relocate certain waterline facilities; and,

WHEREAS, upon the review of borings of the subsurface conditions at the site, it has been determined that additional work is needed due to the unanticipated presence of rock; and,

WHEREAS, to effect this additional work for the relocation, the County and the Public Water Supply District #16, have negotiated the attached Addendum No. 1 to agreement, with costs to be paid by the County in the amount of \$2,273.00; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the attached Addendum No. 1 to agreement is hereby approved and that the County Executive is hereby authorized to execute the Addendum on behalf of the County; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract...Attorney

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
