ORDINANCE # 3765, May 9, 2006

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

Section 1. The Zoning Order of Jackson County, Missouri, and the official maps which are a part

thereof, are amended by changing the boundaries of the "A" (Agricultural) District and the "RR" (Residential Ranchette) District, so that there will be transferred from District A to District RR, a tract of land described as follows:

Description:

The 10 \pm acres are generally located $\frac{1}{4}$ \pm of a mile south of Lone Jack-Lee's Summit Road on the west side of Gammon Road and is specifically described as:

Description: The south ½ of the south ½ of the northeast quarter of the southwest quarter of Section 16, Township 47, Range 30 in Jackson County, Missouri aka 12820 S. Gammon Road.

<u>Section 2</u>. The Legislature, pursuant to the application of Randal W. and Connie E. Brown (RZ-2006 -395), requesting the amendment embodied in this Ordinance and with notice that the Jackson County Plan Commission, by a vote of 4 to 3, recommended approval of this application in a public hearing on April 20, 2006, does adopt this Ordinance pursuant to the Jackson County Charter authorizing the Legislature to exercise legislative power pertaining to planning and zoning.

Effective Date: This Ordinance shall be effective immediately upon its signature by the County Executive.
