WHEREAS, the County did, by Resolution 12194, dated April 27, 1998, enter into a contract with Superior-Bowen Asphalt Company of Kansas City, MO, in the amount of \$1,053,316.35, for the 1998 Road Surface Rehabilitation and Reconstruction Project, No. 2370; and,

WHEREAS, subsequent change orders have adjusted the contract amount to the current authorization of \$1,335,302.86; and,

WHEREAS, all work contemplated by the original contract has been completed and is fully acceptable to the County and final payment on the contract in the amount of \$10,784.80 is now due; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract...Attorney
