BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Legislature be authorized to hold a closed meeting during the regularly scheduled meeting of the Legislature on Monday, June 14, 2021, pursuant to sections 610.021(1) and (2), RSMo, and closing all records prepared in connection therewith.
