RESOLUTION #11034, November 27, 1995

INTRODUCED BY Lisa White Hardwick, County Legislator

WHEREAS, the voters of Jackson County approved imposition of a sales tax for seven years to provide funding for the fight against illegal drugs in our community; and,

WHEREAS, the proceeds and interest generated from this tax are deposited in a special Anti-Drug Sales Tax Trust Fund that is segregated and not commingled with the general fund or any other special funds of the County; and,

WHEREAS, the voters approved the sales tax such that a portion of the proceeds could be used for deferred prosecution, treatment, and rehabilitation; and,

WHEREAS, the Anti-Drug Sales Tax Fiscal Commission desires to assist in the provision of services and has recommended the expenditure of anti-drug sales tax funds for the Full Employment Council to fund its Work Connection project; and,

WHEREAS, the attached Agreement adequately sets forth the full agreement and understanding of the parties; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute the attached Agreement with the Full Employment Council; and,

BE IT FURTHER RESOLVED that the Manager of the Division of Finance be and hereby is authorized to make all payments, including final payment on the Agreement...Attorney

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
