AN ORDINANCE amending the zoning districts established pursuant to the Unified Development Code by rezoning a certain 6.75± acre tract from District AG (Agricultural) to District RE (Residential Estates) and rezoning a certain 12.07± acre tract from District RE (Residential Estates) to District AG (Agricultural).

ORDINANCE NO. 5776, August 14, 2023

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

<u>Section 1</u>. The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "AG" (Agricultural) and "RE" (Residential

Estates) Districts, so that portions will be transferred from District AG to District RE and District RE to
District AG of two tracts of land legally described as follows:
Lot 1A, Flamingo Acres Replat, a subdivision in Jackson County, Missouri
Tract B, Flamingo Acres Replat, a subdivision in Jackson County, Missouri
Section 2. The Legislature, pursuant to the application of the James & Gina Stuelke Trust (RZ-2023-
653), requesting the amendment embodied in this Ordinance and with notice that the Jackson
County Plan Commission voted 6 to 0 to recommend APPROVAL of this application after a public
hearing on July 20, 2023, does hereby adopt this Ordinance pursuant to the Jackson County Charter
authorizing the Legislature to exercise legislative power pertaining to planning and zoning.
Effective Date: This Ordinance shall be effective immediately upon its signature by the County Executive.
