RESOLUTION 10325, May 16, 1994

INTRODUCED BY Lisa White Hardwick, County Legislator

WHEREAS, the voters of Jackson County, Missouri, approved imposition of the sales tax for seven (7) years to provide funding for the fight against illegal drugs in our community; and,

WHEREAS, the Legislature authorized local matching funds through Ordinance 2267; and,

WHEREAS, the Midwest Christian Counseling Center has received grants from the Episcopal Church Center, through the Diocese of Western Missouri, and Lantz Welch Charitable Foundation, in the aggregate amount of \$6,500, for Midwest's "Street Psyche" program; and,

WHEREAS, Midwest has requested matching funds in the amount of \$2,600.00 to implement its program; and,

WHEREAS, the Prosecuting Attorney has reviewed this request and recommends funding in the amount of \$2,600.00; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Prosecuting Attorney is hereby authorized to execute the attached agreement with Midwest Christian Counseling Center; and,

BE IT FURTHER RESOLVED that the Manager of the Division of Finance is hereby authorized to make all payments, including final payment on this Agreement.
