WHEREAS, the Project NeighborH.O.O.D. has received a three-year grant from The Robert Wood Johnson Foundation in the amount of \$1,900,000.00, for participation in the Foundation's Fighting Back: Community Initiatives to Reduce Demand for Illegal Drugs and Alcohol Program; and,

WHEREAS, the Project NeighborH.O.O.D. has requested County Anti-Drug Sales Tax matching funds in the amount of \$150,000.00 to implement the program in 1997; and,

WHEREAS, the Prosecuting Attorney has reviewed this request and recommends the expenditure of these funds; therefore,
BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive is hereby authorized to execute an agreement with the Project NeighborH.O.O.D. in a form approved by the County Counselor; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is hereby authorized to make all payments, including final payment on this Agreement...Attorney
Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
