A RESOLUTION authorizing the purchase of proprietary carbonated soft drinks for resale by the Parks and Recreation Department at its concessions operations from Coca-Cola Bottling Company of Lenexa, KS (\$65,000.00), and Pepsi Cola General Bottlers of Olathe, KS (\$25,000.00) at an estimated aggregate cost to the County not to exceed \$90,000.00.

RESOLUTION # 14030, February 25, 2002

INTRODUCED BY Fred Arbanas, County Legislator

WHEREAS, § 1040.6 of the Jackson County Code, 1984, dispenses with the requirement of competitive bidding for the purchase of proprietary articles, i.e., goods manufactured under an exclusive individual right to make and sell them, which are to be offered for resale at certain retail outlets operated by the Parks and Recreation Department; and,

WHEREAS, pursuant to § 1040.6, the Purchasing Director recommends the issuance of purchase orders to Coca-Cola Bottling Company of Lenexa, KS, and Pepsi Cola General Bottlers of Olathe, KS, for the furnishing of proprietary carbonated soft drinks to be offered for resale by the Parks and

Recreation Department at its concessions operations, in the estimated aggregate amount of \$90,000.00; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Purchasing Director be and hereby is authorized to issue purchase orders in the aggregate amount of \$90,000.00 to Coca-Cola Bottling Company of Lenexa, KS, and Pepsi Cola General Bottlers of Olathe, KS; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance be and hereby is authorized to make all payments including final payment on the contracts thereby made.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
