A RESOLUTION authorizing the County Executive to execute a Water Line Easement in favor of Public Water Supply District No. 17.  
RESOLUTION # 11242, April 1, 1996

INTRODUCED BY Fred Arbanas, County Legislator

WHEREAS, Public Water Supply District No. 17 has requested a water line easement on a portion of the perimeter of Monkey Mountain Park to extend an existing line to provide service for private residential development; and,

WHEREAS, this easement is 15 feet wide and immediately adjacent and parallel to the right-of-way for 40 Highway; and,

WHEREAS, a fee shall be assessed in the amount of \$425, based on \$1.25 per lineal foot; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri that the County Executive be and hereby is authorized to execute a Water Line Agreement in favor of Public Water Supply District No. 17, to carry out the above-stated purposes in a form as approved by the County Counselor.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
