IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE amending the zoning districts established pursuant to the Unified Development Code by changing from District A (Agricultural) to District RR (Residential Ranchette) a certain 10± acre tract.

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

<u>Section 1</u>. The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "A" (Agricultural) District and the "RR" (Residential Ranchette) District, so that there will be transferred from District A to District RR, a tract of land described as follows:

Description:

The 10 ± acres are located at the northwest corner of Hammond Road and Corn Road and are specifically described as all that part of the west 40 acres of the south ½ of the southeast ¼ of Section 35, Township 48, Range 30, in Jackson County, Missouri, described as:

Beginning at a point on the south line of said ¼ section 484.62 feet east of the southwest corner thereof; thence north 0 degrees 04 minutes east parallel to the west line of said ¼ section, 123 feet; thence east parallel to the south line of said ¼ section 175.38 feet; thence north 0 degrees 04 minutes east parallel to the west line of said ¼ section 539.46 feet to a point 660 feet south of the north line of said west 40 acres; thence south 89 degrees 48 minutes 52 seconds east parallel to the north line of said west 40 acres 658.01 feet to the east line of said west 40 acres; thence south 0 degrees 04 minutes west along said east line and parallel to the west line of said ¼ section 660.35 feet to the south line of said ¼ section; thence west along said south line 833.38 feet to the point of beginning, except that part in road a/k/a 33404 E. Hammond Road.

<u>Section 2</u>. The Legislature, pursuant to the application of Timothy Moulis (RZ-2006-391), requesting the amendment embodied in this Ordinance and with notice that the Jackson County Plan Commission voted unanimously to recommend approval of this application at a public hearing on February 16, 2006, does adopt this Ordinance pursuant to the Jackson County Charter authorizing the Legislature to exercise legislative power pertaining to planning and zoning.

Effective Date: This Ordinance shall be effective immediately upon its signature by the County Executive.
