INTRODUCED BY John Patrick Burnett, County Legislator

WHEREAS, the County and Historic Northeast Restoration Committee, Inc., desire to enter into an agreement, a copy of which is attached hereto and incorporated herein, whereby the County will pay Historic Northeast Restoration Committee, Inc., \$80,000.00 to be used by it to assist in the revitalization and redevelopment of 3.6 miles of the Independence Boulevard/Avenue Corridor; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the agreement is hereby approved and that the County Executive is authorized to execute the agreement on behalf of the County; and,

BE IT FURTHER RESOLVED that the Manager of the Division of Finance is authorized to make all payments, including final payment on the agreement.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
