ORDINANCE #4045, October 13, 2008

INTRODUCED BY Henry C. Rizzo, County Legislator

WHEREAS, the rooms that house the servers at the downtown courthouse, the Public Works Tech

Center, and the Circuit Court server room, do not currently include any fire suppression systems, and the IT Department is requesting the installation of fire suppression systems to avoid a complete shut down should a fire occur; and,

WHEREAS, an appropriation is necessary to cover these costs; and,

WHEREAS, the County Executive recommends said appropriation; now therefore,
