ORDINANCE #3036, July 24, 2000

INTRODUCED BY Victor E. Callahan, County Legislator

WHEREAS, since 1986, changes in the Collections, Assessment, and Records Departments have taken place which have caused an increase of revenue to the County, as well as an increased workload for current employees; and,

WHEREAS, new positions are needed within these departments in order to accommodate the increased workload and address salary issues within these departments; therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following transfer within the 2000 General Fund and appropriation from the unappropriated surplus of the 2000

Assessment Reimbursement Fund be and hereby are made to cover the salaries and benefits of new positions within the Collection, Assessment, and Records Departments and address salary issues within these departments:
