WHEREAS, the Prosecuting Attorney has recommended that Pan Educational Institute (PEI) be retained to oversee and implement the "COMBAT in the Community" initiative, in cooperation with the Prosecuting Attorney's Office; and,

WHEREAS, under this proposal, PEI will coordinate, plan, and execute all "COMBAT in the Community" outreach efforts, including seminars, conferences, and meetings, at a cost to the County not to exceed \$5,000.00; now therefore,

BE IT RESOLVED that the County Executive be and hereby is authorized to execute a Consulting Agreement with Pan Educational Institute in a form to be approved by the County Counselor; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to make all payments, including final payments on the agreement.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
