WHEREAS, the program emphasizes the cooperative approach to water quality public education to

meet the U.S. Environmental Protection Agency regulatory requirements; and,

WHEREAS, Jackson County has participated in this program since 2003; and,

WHEREAS, the WQE Program is in the best interest of the health, safety, and welfare of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Director of Finance and Purchasing be and hereby is authorized to issue a check to the Mid-America Regional Council, in the amount of \$2,500.00 for the 2012 Water Quality Education Program.
