INTRODUCED BY Dan Tarwater, County Legislator

WHEREAS, the Mid America Assistance Coalition (MAAC) has been awarded private grants from the Kansas City Power and Light Co. and Missouri Gas Energy, in the aggregate amount of \$330,000.00, for the purpose of providing utility assistance funds to clients of the Drug Court Program; and,

WHEREAS, MAAC has requested matching funds in the amount of \$10,000.00 for its program; and,

WHEREAS, the Prosecuting Attorney has reviewed this proposal and recommends the expenditure of these funds; and,

WHEREAS, the attached Agreement provides a suitable mechanism by which these matching funds can be transferred to MAAC; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive is hereby authorized to enter into an agreement, a copy of which is attached and incorporated herein by reference, with MAAC to provide utility assistance funds to clients of the Drug Court Program; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance be and hereby is authorized to make all payments, including final payment on the Agreement.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
