WHEREAS, the purpose of such closed meeting is to conduct privileged and confidential communications between the Legislature and the Jackson County Counselor concerning the hiring, firing, disciplining, or promoting of particular County employees and concerning individually identifiable personnel records; and,

WHEREAS, such closed meeting is allowable under sections 610.021(3) and (13) of the Revised Statutes of Missouri; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Legislature be authorized to hold a closed meeting during the regularly scheduled meeting of the Legislature on Monday, July 22, 2019, pursuant to sections 610.021(3) and (13), RSMo, and closing all records prepared in connection therewith.
