WHEREAS, the Legislature finds that the Buckner Tarsney Road project by the City will benefit the citizens of Grain Valley and the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that, pursuant to Chapter 28, <u>Jackson County Code</u>, 1984, the Director of Finance and Purchasing is authorized to issue a check in the amount of \$57,004.62 as a lump-sum payment to the City of Grain Valley for use by the City on the Buckner Tarsney Road project.
