WHEREAS, throughout the County, Jay is known for being the “go to guy” on all County matters, with a willingness to patiently explain to each new administration its obligations and responsibilities under the County code and Charter; and,

WHEREAS, Jay’s contribution to the efficient and unwavering function of Jackson County is immeasurable, and every long-serving County associate has a story to tell of Jay’s input and support; and,
