WHEREAS, the attached Agreements set out the rights and obligations of the parties; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the and Chairman of the Legislature be and is authorized to execute the attached Agreements with William F. Waris, Alvin Nash, and W. T. Dawson; and,

BE IT FURTHER RESOLVED that the Manager of the Division of Finance be and is authorized to make all payments, including final payment on the Agreements...Attorney
