WHEREAS, Jackson County has been awarded \$60,000.00 by the Kansas City Metropolitan Crime Commission for the partial funding of one full-time prosecutor as part of Project Safe Neighborhood;

and,

WHEREAS, this grant is to assist in the prosecution of federal and/or state criminal charges related to firearm crimes in Jackson County as part of Project Safe Neighborhood and 50% are estimated to

be related to illicit drug activity; and,

WHEREAS, the total cost of the project is \$86,010.00 and requires matching funds of \$26,010.00

from the Anti Drug Sales Tax Fund Grant Match account; and,

WHEREAS, the grant term is from January 1, 2005 through December 31, 2005 and the parties

desire to enter into Amendment 2 for the continuation of Project Safe Neighborhood, a copy of which

is attached hereto; and,

WHEREAS, a transfer and appropriation are necessary in order to place the grant and matching

funds in the proper spending accounts; and,

WHEREAS, the County Executive recommends said transfer and appropriation and the execution of

the agreement; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following transfer
