ORDINANCE 2757, November 24, 1997

WHEREAS, Section 3.3 of the Capital Improvement Project Lease Agreement between Jackson County and the Jackson County Public Facilities Authority requires the Jackson County Legislature to annually adopt an Ordinance setting forth:

- 1) the renewal of the Lease for an additional one-year term; and,
- 2) an assurance that funding for the rental payments and other additional payments has been encumbered in the County's annual budget; therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the lease agreement between Jackson County and the Jackson County Public Facilities Authority is hereby renewed for an additional one-year term; and,
