ORDINANCE #4034, September 15, 2008

WHEREAS, the Prosecuting Attorney's Office has been awarded a grant by the Missouri Department of Public Safety in the amount of \$218,948.00 for its Drug Abatement Response Team (DART) program for salaries and benefits of three assistant prosecutors, two investigators, and a paralegal in the Prosecuting Attorney's Office and for contractual services through the City of Kansas City, Missouri; and,

WHEREAS, the DART program is a cooperative effort of the Prosecuting Attorney's Office and the City of Kansas City to target and close down drug houses within the city; and,

WHEREAS, the grant is subject to a local match in the amount of \$156,929.00; and,

WHEREAS, an appropriation and transfer are necessary in order to place the grant and matching funds in the proper spending accounts; and,

WHEREAS, the County Executive recommends this appropriation and transfer; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following transfer and appropriation within the fund balance of the 2008 Anti-Drug Sales Tax Fund be and hereby is made:
