WHEREAS, by Ordinance 3790, dated July 17, 2006, the Legislature did accept a grant awarded to the Family Court Division by the Office of State Courts Administrator for juvenile detention alternatives initiative programs; and,

WHEREAS, the Office of State Courts Administrator has granted an extension of this grant program through October 31, 2006, to continue funding juvenile alternatives initiative programs previously

authorized by Ordinance 3790; and,

WHEREAS, the Legislature has determined that an extension of this grant, at no cost to the County, is in the best interests of the health, welfare, and safety of the citizens of the County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Juvenile Detention Alternatives Initiative Grant is hereby extended through October 31, 2006.
