WHEREAS, he has received bids from Lady Baltimore of Kansas City, KS, Riteway Magic Supply of Kansas City (Jackson County), and Central Poly of Linden, NJ; and,

WHEREAS, the Purchasing Director has recommended that award be made to Lady Baltimore of Kansas City, KS, for the reason that it has submitted the lowest and best bid in compliance with the bid's specifications, as set out in the attached recap and analysis; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract, to the extent sufficient appropriations to the using spending agency have heretofore been made in the current Jackson County budget.
