WHEREAS, the County has been awarded a grant in the amount of \$75,000.00 by the Mid-America

Regional Council Solid Waste Management District to promote waste reduction and recycling in the Jackson County park system; and,

WHEREAS, the attached Grant Assistance Agreement provides a suitable mechanism by which to effect the acceptance of the grant proceeds; and,

WHEREAS, the grant is subject to a \$25,000.00 local match; and,

WHEREAS, in order to place the grant proceeds and matching funds in the proper spending accounts, an appropriation and transfer are necessary; and,

WHEREAS, the County Executive recommends said appropriation and transfer; now therefore,
