ORDINANCE 2305, July 18, 1994

WHEREAS, changing traffic patterns and updated traffic engineering studies indicate the need to amend the County's present load limits to delete a certain schedule change; therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, as follows:

Section A. Enacting Clause. Schedule B of Chapter 53 of the Jackson County Code, 1984, is
