Bridges, in the amount of \$800.00; and,

WHEREAS, the owners have agreed to convey said right-of-way and temporary construction easement, and to settle the claim for damages and have executed conveyances in favor of the County in consideration of the total payment of \$800.00; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Director of the Department of Finance issue a check in the amount of \$800.00 in the name of Byron R. and Linda K. Bridges, and that the check be delivered to the Department of Public Works, Kaye Merkle, Engineering Division, for appropriate disposition...Attorney
