WHEREAS, the City of Lee's Summit, Missouri, is willing to make available the City's wash bay facility for use by the Jackson County Public Works Department to clean and maintain County owned and operated dump trucks and related equipment; and,

WHEREAS, the County desires to use these facilities because the County does not own such a facility and the fees charged by the City are much lower than those of private facilities; and,

File #: 16840, Version: 0 WHEREAS, the attached Intergovernmental Cooperative Agreement sets forth the mutual responsibilities and obligations of the parties for provision and payment of the services described above; and, WHEREAS, this Agreement is in the best interest of the health, welfare, and safety of the citizens of the County; now therefore, BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute the attached Intergovernmental Cooperative Agreement with the City of Lee's Summit, Missouri, for use of City's wash bay facility, at a cost to the County not to exceed \$5,000.00; and, BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to make all payments, including final payment on the Agreement.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
