WHEREAS, the Prosecuting Attorney=s Office has been awarded a grant in the amount of \$124,536.80 by the Missouri Department of Public Safety for the office=s Victim Services Program for the period July 1, 2013, through June 30, 2015; and,

WHEREAS, the grant will cover partial funding for the salary, benefits, and training costs for two

WHEREAS, a match of \$60,369.11 is required for this grant; and,

WHEREAS, a transfer and appropriation are necessary in order to place the grant and matching funds in the proper spending accounts; and,
