AN ORDINANCE amending the districts established by the Jackson County Zoning Order by changing from A (Agricultural) to RS (Suburban), a certain 1 ± acre tract.

ORDINANCE 3146, May 30, 2001

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

<u>Section 1</u>. The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "A" (Agricultural) District and the "RS" (Suburban) District so that there will be transferred from District A to District RS a tract of land described as follows:

Description: A 1 ± acre lot legally described as Lot 39, Trophy Estates, a subdivision in Jackson County, Missouri lying in the southeast quarter of Section 13, Township 47, Range 31 aka 25302 E. 130th Street. Trophy Estates Subdivision is approximately one mile south of US Highway 50 on the west side of Harris Road.
