**ORDINANCE #3222**, January 22, 2002

WHEREAS, the Jackson County Parks and Recreation Department has been awarded a grant in the amount of \$64,888.00, for the Little Blue Trace Bicycle Trail access improvements, under the FY2001 Transportation Enhancement Program administered by the Missouri Department of Transportation; and

WHEREAS, these funds are subject to a local match in the amount of \$21,629.00; and,

WHEREAS, the Jackson County Wheelman have donated \$10,700 to provide a portion of this local

match; and,

WHEREAS, and appropriation is necessary to place the matching funds in the proper spending account; and,

WHEREAS, the County Executive recommends said appropriation as an amendment to her 2002 recommended County budget; therefore,
