WHEREAS, Swope Health Services has submitted a proposal for funding for 2005-2006 from the Anti-Drug Sales Tax Fund to provide comprehensive substance abuse treatment and mental health services to clients of the Jackson County Mental Health Court, in the amount of \$407,000.00; and,

WHEREAS, funding of this proposal is in the best interests of the health, welfare and safety of the citizens of Jackson County; and,

WHEREAS, an appropriation is necessary in order to fund a portion of the cost of these services; now therefore.
