ORDINANCE #4150, September 14, 2009

WHEREAS, the Missouri Department of Transportation, Highway Safety Division, has awarded the Sheriff's Office a "Youth Alcohol Enforcement" grant in the amount of \$11,970.00 for the period October 1, 2009, through September 30, 2010; and,

WHEREAS, in 2008, the number of under 21 alcohol involved crashes, fatalities, and personal injuries increased; and,

WHEREAS, the Jackson County Sheriff's office will conduct Compliance Checks on county-wide liquor stores and bars suspected of selling alcohol to minors; and,

WHEREAS, the Sheriff recommends the use of the grant funds for reimbursement of overtime used for the "Youth Alcohol Enforcement" program; and,

WHEREAS, an appropriation is necessary to place the grant funds in the appropriate spending account; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be made from the unappropriated surplus of the 2007 Grant Fund:
