WHEREAS, the Purchasing Director has solicited formal written bids on Bid No. 27-99 for the furnishing of live bait for use by the Parks and Recreation Department; and,

WHEREAS, following evaluation of the bids submitted, the Purchasing Director recommends that the contract be divided and awarded to the vendors submitting the lowest bid for each item; and,

WHEREAS, award as recommended would result in estimated awards for the respective vendors as follows:

Keller's Bait Farm Buckner, MO	\$10,000.00
Minnesota Bait & Fly Co. Kansas City, KS	\$5,000.00

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract to the extent sufficient appropriations to the using spending agency have heretofore been made in the current Jackson County budget...Attorney
