ORDINANCE #3062, September 5, 2000

Kansas City Community Foundation and The Ewing Marion Kauffman Foundation to cover costs incurred by the County in the development of its Stakeholder Assessment, "A Vision For The Future"; and,

WHEREAS, an appropriation is necessary to allow these funds to be spent; and,

WHEREAS, the County Executive recommends this appropriation as an amendment to her proposed 2000 Jackson County Budget; now therefore,
