ORDINANCE #4431, July 23, 2012

WHEREAS, the Jackson County Drug Task Force has received an Edward Byrne Justice Assistance Grant (JAG) from the U.S. Department of Justice in the amount of \$180,620.00; and,

WHEREAS, the grant proceeds will be used to fund one full-time criminalist forensic chemist, and three full-time officers' salaries and overtime; and,

WHEREAS, the grant is subject to a local match in the amount of \$60,207.00; and,

WHEREAS, a transfer and appropriation are necessary to place the grant and matching funds in the proper spending accounts; and,

WHEREAS, the County Executive recommends said transfer and appropriation; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following transfer and appropriation within the 2012 Anti-Drug Sales Tax Fund be and hereby are made:
